## TERMS AND CONDITIONS

- We will require our booking form to be completed with a cheque\* posted to the address below and made payable to Mrs Jane Dgebuadze. Once the non-refundable deposit of £100\* has been paid, we will confirm your booking via E-Mail or other means if required.
- The outstanding balance must be paid 6 weeks before commencement of your holiday. If the booking is made within 6 weeks of departure, the full amount is required.
- A separate £100\* cheque will be required as damage insurance/ key deposit, together with the final payment. Provided no damage is caused to the property, this cheque will not be cashed and will be destroyed when the keys to the property are returned to us.
- The owners shall not be responsible for any force majeure circumstances that might affect the holiday, including, but not confined to, strikes, terrorist activities, war or threat of war, riot, civil strife, industrial disputes, natural or nuclear disaster, construction work, fire or adverse weather conditions.
- We accept no liability for any injuries, death, accident, illness or misadventure incurred during use of the property. We recommend that full Holiday Insurance be taken out.
- Cancellation: 30-55 days – 50% of payment, less deposit. Less than 28 days before departure – no refund given.
- The maximum number of persons allowed in the apartment is 6/8 (2-beds/3-beds).
- Representatives of the owners shall be allowed any reasonable access to the property during the Holiday Tenancy.
- You, the Holidaymaker, agree to abide by the dates set for the duration of your holiday, from 3.00 pm on the day of arrival until 10.30 am on the day of departure. Alternative times may be available on request.
